

## Reciprocating TS/TSD Series Compressors

ELGI warrants that its product and the components of its products will perform the purpose and function for which they are designed and intended, for the periods of time indicated below when used, serviced and maintained in accordance with ELGI instructions and specifications. If an ELGI product or component of an ELGI product fails to perform as warranted, due to defects in material or workmanship, ELGI will, at its option, repair or replace the product or component of the product as indicated and upon the terms and provisions set forth below.

### Warranty Coverage

**Basic Pump:** 12 months from date of purchase. Parts only, no labor or travel included

**Compressor Package:** 1 - 12 months from date of purchase. Parts, labor and approved travel included.

13 – 36 months from date of purchase, Pump only, labor and travel not included.

**Parts:** 90 days from the date of purchase. Labor not included.

### Warranty Conditions

Warranty will be applicable only if:

1. Proof of purchase must be kept on file and submitted if requested.
2. Compressor must be installed and operated as per ELGI'S recommended guidelines.
3. Normal consumable parts such as Belts, filters, check valves etc are excluded
4. Use only ELGI'S genuine spares, consumables & lubricants at all times.
5. Warranty travel mileage may not exceed 100 miles.
6. All repairs of a warranty nature must be completed by an authorized ELGI Authorized Distributor.
7. Maintenance instructions and schedules must be followed as outlined in the operation and maintenance manual
8. ELGi will pass along original manufacturers' warranty on parts not manufactured by ELGI.
9. For any warranty claim, all the terms of this warranty policy will apply without regard to the length of the applicable warranty.
10. Warranty claim forms must be submitted in writing within 30 days of the failure by the authorized ELGI Distributor.
11. ELGI reserves the right to repair or replace the part proved defective and request return of defective part for inspection within 30 days of such request. ELGI will pay the freight of parts it requests to be returned.
12. Warranty Policy shall cover only parts as mentioned under scope of this document and not any other part.

**Conditions that will Void or Invalidate the Warranty**

1. Failure to abide by the warranty conditions unless otherwise given in writing by ELGI
2. Repairs carried out on the compressor unit without prior authorization by ELGI.
3. Nonconformity to ELGI operating instructions, specifications, guidelines, maintenance and service instructions.
4. Equipment conditions as a result of normal wear and tear, abnormal or unusually harsh operating conditions, negligent use of equipment, accidents and shipping damage.
5. If maintained/serviced by unauthorized personnel.

**Limitation of Liability:**

- The benefits of this warranty shall be to the first owner or commercial user only and cannot be transferred.
- ELGI shall not be liable for any loss of profit, loss of production, loss of income or contract, loss of goodwill, or for indirect or consequential or incidental loss or damage of any kind whatsoever.
- In no event ELGI shall be liable for any claims or loss having a value higher than the original purchase price of the product.
- ELGI reserves the right to alter or terminate the Extended Warranty program or any part for units not already covered by the Extended Warranty.
- The warranty expressly set forth herein is the only warranty provided by ELGI with respect to its products and ELGI expressly denies and disclaims all other warranties, either expressed or implied and specifically disclaims any implied warranty of merchantability or fitness for a particular purpose.

**Force Majeure:** ELGI is not liable for failure to perform the company's obligations if such failure is as a result of Acts of God (including but not limited to fire, flood, earthquake, storm, hurricane or other natural disaster), war, invasion, act of foreign enemies, hostilities (regardless of whether war is declared), civil war, rebellion, revolution, insurrection, military or usurped power or confiscation, terrorist activities, nationalization, government sanction, blockage, embargo labor dispute, strike, lockout or interruption or failure of electricity or telephone service
